## **OPERATION REGULATIONS:**

ALL GOLF CARTS ARE TO STAY PARKED IN PIT STALL DURING ALL OF THE FEATURE RACES. NO USE OF GOLF CARTS DURING FEATURE UNLESS PERMISSION IS GIVEN BY AN OFFICIAL.

- 1. All operators of golf carts shall be licensed to operate a motor vehicle as provided by the Connecticut DMV and shall carry a valid Connecticut driver's license while operating the golf cart.
- 2. All operators shall abide by all traffic regulations, shall not stop or park golf cart in any roadway, shall follow directions of all officials.
- 3. Golf carts shall abide by all poste speed limits and may not operate at a speed greater than 15mph at any time in the paddock area.
- 4. Golf carts shall move to the right and yield the right of way of any official, emergency, and race vehicles.
- 5. The golf carts shall only be used in the paddock area. Golf carts shall not go up the south entrance roadway to victory lane, they shall park them by the south tower.
- 6. NO golf carts or motorized vehicles shall be allowed on the midway or grandstand area.
- 7. The operator and every occupant of a golf cart shall be limited to the seating capacity as designed by the manufacturer and all occupants shall remain seated in a seat designed to hold passengers while the golf cart is in motion.
- 8. No person may ride in the lap of the driver or any other occupant.
- 9. Children (under the age of 16) will be properly secured a protected while vehicle is in motion.
- 10. A person who violates a provision of the Ordinance is guilty of a misdemeanor which is punishable by a fine not less than \$1.00 and not to exceed \$500.00. May also lose the right to operate said golf cart on the property of the New London Waterford Speedbowl. Any offence shall be handed out by the Speedbowl management as they feel deemed.
