Car Number Registration

- A. The deadline for car number renewal used during the 2022 season is March 15, 2023. If registration form and fee are not received at the New London-Waterford Speedbowl office by the renewal date, the car number will no longer be reserved and will become available for claim.
- B. If a car number was registered in the 2022 season but the team did not attempt to qualify for an event, the renewal rights for that car number will be forfeited.
- C. After the registration deadline car number assignments are made on the availability of numbers at the time applied.
- D. One duplicate number is allowed but must include a trailing identifier (ex: "X", "CT", etc). 3 or more digit numbers are not permitted.
- E. The New London-Waterford Speedbowl Management reserves the right to assign numbers at their discretion.
- F. Car owner holds the rights to the car number.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.
