Car numbers that were purchased and used in the 2017 are available to that same purchaser up until the deadline outlined in the **CAR NUMBER RENEWALS** section below. Any number not renewed by the deadline will become available to others. Please refer to the rules for your particular division regarding the size and numerals allowed in competition. If you are registering more than one car and/or division you must submit multiple forms.

**CAR NUMBER RENEWALS:** The deadline for the renewal of your 2017 car number is at **5pm, Feb. 20, 2018**. In the event your registration form and \$35 fee are not at the New London – Waterford Speedbowl office by the deadline your number will no longer be reserved for you and may be available for claim by another competitor. Confirmation of your 2018 car number will be emailed to you with 3 days of your form and payment arriving. **You MUST supply a valid email address to register a car number.**

**Note:** If you purchased a car number in 2017, but did not attempt to qualify a car with that number in 2017, you may not have the renewal rights to that number.
