### Car Number Registration

- --ALL information within the Registration Form and W9 MUST be completed at time of submission, or full registration will be returned to Owner for completion.
- --Minor drivers require the submission of minor paperwork, signed by both parents and MUST be notarized.
- -- Car owner holds the rights to car number.
- --To guarantee receipt of car number used during 2023 season, car must have competed in at least one race. If not, the rights for that car number will be forfeited unless you are first to request.
- --The deadline date to secure your car number used during the 2023 season is April 1, 2024. If registration form and fee are not recieved by the New London-Waterford Speedbowl by deadline date, the car number will be considered available for use.
- --One duplicate car number per division is allowed but must include a trailing identifier (ex: "X", "CT", etc).
- --Three (3) or more digit numbers are not permitted.
- --The New London-Waterford Speedbowl Management reserves the right to assign numbers at their discretion.

#### **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding,
